



Call for Applications for Admission to the English-Taught Master's Degree Programme "Logistics & Supply Chain Management"

Department of Economics
Academic Year 2026–2027

The Department of Economics of the School of Economic and Political Sciences of the Aristotle University of Thessaloniki announces the operation of the Master's Degree Programme (MSc) "Logistics & Supply Chain Management" for the academic year 2026–2027, which awards a **Master's Degree (MSc)**.

The Programme is addressed to graduates of Departments of Business Administration, Economics, Natural Sciences, Informatics, Electrical Engineering, Mechanical Engineering, Computer Engineering, as well as other Departments of Greek Universities and equivalent, officially recognized foreign institutions. Graduates of former Technological Educational Institutes (TEI) in related fields are also eligible, as well as business professionals with relevant work experience.

The Programme is offered with the option of **distance learning (online attendance)**¹. Examinations are conducted **in person**.

Full-time study: Minimum and compulsory duration of studies: **three (3) semesters**. Students are required to contribute to the operational costs of the Programme with tuition fees amounting to **two thousand two hundred fifty euros (€2,250)** per semester of coursework and **five hundred euros (€500)** for the thesis semester.

Part-time study²: Minimum and compulsory duration of studies: **five (5) semesters**. Students are required to contribute to the operational costs of the Programme with tuition fees amounting to **one thousand five hundred euros (€1,500)** per semester of coursework and **five hundred euros (€500)** for the thesis semester.

Application Periods

International applicants: from 1/3/2026 to 30/4/2026

Greek applicants: from 1/5/2026 to 30/6/2026

Applicants who are expected to obtain their degree by the date of enrolment in the Programme may also apply.

² Upon submission of an application, accompanied by the required supporting documents and approval by the Committee. Applicants must provide evidence of employment or engagement of at least 20 hours per week.

REQUIRED DOCUMENTS

1. Application form (completed online via the Programme website).
2. Curriculum Vitae.
3. Copy of Bachelor's degree or diploma (Degree or diploma certificate (with recognition of equivalence and correspondence from the Hellenic NARIC if obtained abroad)³).
4. Official transcript of undergraduate and/or postgraduate studies (if applicable).
5. Two (2) letters of recommendation (at least one academic).
6. Proof of English language proficiency at **C2 level** (C2 / Γ2 / CPE).
7. Scientific publications, distinctions (if any).
8. Certificates of professional experience (if any).
9. Copy of National ID Card or Passport.
10. Photograph.
11. Research activity (if any).

Evaluation Criteria

1. Overall degree grade, type of degree, or ranking among peers – **40%**
2. Performance in the personal interview – **10%**
3. Professional experience – **20%**
4. Research activity, publications, postgraduate studies – **20%**
5. Other qualifications (GMAT performance, additional degrees or postgraduate titles, extra foreign languages, seminars) – **10%**
